NOTIFICATION

On the recommendation of Covid-19 Cell of Ranchi University and on the direction of the State Government, the Vice-Chancellor has been pleased to pass the following orders:

1. The University office, University Departments, Allied offices and all Colleges under Ranchi University will work from home till 13.05.2021 while need based employee may work in the office following UGC guidelines and Govt. directives.
2. Online classes and online examination shall continue till further order.
3. To conduct MBBS 3rd Professional Part-II (Annual) examination and MD/MS/M.Ch./Diploma (Annual) examinations offline from 01.06.2021, The Vice Chancellor, Ranchi University has sent a letter to Additional Chief Secretary, DHTE, Jharkhand and seek permission to conduct final year examination in offline mode as proposed by Director, RIMS, Ranchi. Once we receive permission from the Government, then we shall notify the examination schedule.
4. It is directed to Dean, Medicine to provide clear cut recommendation to allow Shalini Kumari (2018-21), ENT, RIMS in the university examination for 2021 following MCI guidelines, who was on maternity leave for a period of six month i.e. (26.03.2020 to 21.09.2020).
5. As reported by Director, EDPC, the payment gateway for B.A./B.Sc./B.Com. Semester-II examinee (2019-22) has been uploaded and accordingly the concerned Principal of the college can approve them for online form filling for B.A./B.Sc./B.Com. Semester-II (2019-22) from 08.05.2021.
6. The list of registered students of M.A./M.Sc./ M.Com. Semester-I (2020-22) has been provided by the DSW to Director, EDPC to generate unique roll number of these students and accordingly will provide marks foil to the concerned Head of the Department and Principal of the college to conduct their mid semester examination.
7. If any instructions issued by the State Govt. on or before 12.05.2021 be released, then it will be automatically implemented.
8. Next meeting of the Covid-19 Cell will be held on 17.05.2021 in Dean's Conference Hall at 11.00 am to decide further course of action.


