NOTIFICATION

In continuation of the previous advisory notified vide memo no. RU/R/6016/20 dated 17.03.2020 and RU/R/6022/20 dated 20.03.2020 and the advisory issued by the Secretary, Ministry of Human Resource Development, Government of India, New Delhi vide memo no- DO. No: Secy (HE)/ MHRD/2020 dated 21.03.2020, the Vice-Chancellor has been pleased order the following as preventive measures to achieve "Social distancing" to fight COVID-19 :

1. Officers of the University, Faculty members, Teachers, Researchers and Non-teaching staff under the administrative control of Ranchi University are permitted and advised to work from home till 31.03.2020.
2. Faculty members, Teachers and Researchers are advised to utilize this period for various academic activities such as :
 - (i) Development of Online content, On-line teaching and online evaluation.
 - (ii) Prepare lesson plan and develop instructional material for the courses to be offered during next academic year/ next semester.
 - (iii) Carry on research works.
 - (iv) Write articles & papers etc.
 - (v) Prepare innovative question for "Question-Bank".
 - (vi) Prepare innovation projects on " Ek Bharat – Shrestha- Bharat" and other topics.
3. The said period shall be counted as being on duty for all officers, Faculty members, Teachers, Researchers, Non-teaching staff including Ad-hoc and contractually appointed teachers, whose contract is valid atleast up to 31.03.2020.
4. Students and Foreign Students who are still in hostel are allowed to continue in their hostels and should take all necessary precaution for their safety. Those who have left hostel are not allowed to come back.
5. All officials, Faculty members, Teachers, Researchers, Non-teaching staff may be contacted in case of emergency. For this they are directed to provide their contact details at respective places.


