**Policy for disable a friendly and barrier-free environment** 

# 1. Preamble:

### 2. Objectives:

The objectives outlined in this Policy are as follows:

- 2.1 Cultivate an inclusive culture within the University that prohibits discrimination, exploitation, or segregation of disabled students and staff across all educational and work-related activities.
- 2.2 Establish a regulatory framework to ensure the efficient and effective provision of services to disabled students and staff within the institution.
- 2.3 Adhere to and implement all applicable legislation concerning individuals with disabilities, ensuring compliance with relevant laws and regulations.
- 2.4 Guarantee equal opportunities and facilitate the full participation of individuals with disabilities in all aspects of academic and professional life within the institution.
- 2.5 Allocate necessary resources and budgetary provisions to successfully achieve the objectives outlined in this Policy.

# **3. Policy Statement:**

Accessibility Standards: Ranchi University will adhere to accessibility standards and guidelines to ensure that all its facilities, programs, services, and activities are accessible to individuals with disabilities. These standards will comply with relevant local regulations and international best practices.

**Infrastructure Accessibility:** The university will regularly assess its infrastructure, including buildings, pathways (Ramp, Lift, Tactile paths etc.), restrooms, and parking facilities, to identify and eliminate barriers to accessibility. New construction and renovations will prioritize universal design principles to ensure inclusivity from the outset.

**Digital Accessibility:** Ranchi University's digital platforms, including websites, learning management systems, and online resources, will be designed and maintained to be accessible to individuals with disabilities. This includes compatibility with screen readers, alternative text for images, and keyboard navigation.

**Support Services:** The university will provide support services and accommodations to students, faculty, and staff with disabilities to ensure their full participation in academic and employment-related activities. This may include assistive technology, sign language interpreters, note-taking services, and accessible transportation options.

Awareness and Training: Ranchi University will conduct awareness programs and training sessions to educate the campus community about disability rights, accessibility issues, and inclusive practices.
