नोट :- उद्धरण दिनांक 18/04/2023 को अपराहन 02:30 बजे निदेशक आई.एल.एस. कार्यालय में खोला जाएगा।
शर्तें :-

- (1). सभी पुस्तकें नये संस्करण में एवं मूल प्रिंट में ही आपूर्ति मान्य होगी, एवं पुराने संस्करण अमान्य होंगी। अगर किसी पुस्तक का नवीन संस्करण प्रकाशित नहीं हुआ है, तो इस आशय का प्रमाणपत्र संलग्न करना होगा।
- (2). आपूर्तिकर्ता को अलग से जी.एस.टी. एवं अन्य टैक्स का अतिरिक्त खर्च देय नहीं होगा।
- (3). आपूर्तिकर्ता को सभी पुस्तक, आई.एल.एस.के पुस्तकालय में लाकर उपलब्ध करानी होगी। इस हेतु कोई अतिरिक्त खर्च देय नहीं होगा।
- (4). आपूर्तिकर्ता द्वारा उपलब्ध कराये गये पुस्तक से संतुष्ट नहीं होने पर आपूर्ति रद्द किया जायेगा।
- (5). आपूर्तिकर्ता अपना आधार कार्ड एवं पैन कार्ड की छायाप्रति स्वः अभिप्रमाणित कर उद्धरण के साथ संलग्न करेंगे।
- (6). निविदाकर्ता पिछले तीन वर्षों का इनकम टैक्स रिटर्नस उद्धरण के साथ संलग्न करेंगे।
- (7). निविदाकर्ता पुस्तकों के कुल निविदित राशि का 5 प्रतिशत EMD, 'B-1 Institute of legal studies, R.U. Ranchi' के नाम पर डिमांड ड्राफ्ट के माध्यम से उद्धरण के साथ जमा करनी होगी। सफल निविदाकर्ता का EMD 6 माह तक जमा रहेगा, असफल निविदाकर्ता का EMD वापस कर दी जाएगी।
