- II. For PGDMP (NO. OF SEATS: 20) - B.Sc. with Biotechnology, Botany, Chemistry, Biochemistry, Agriculture Science of not less than three Academic Years or passed some other examination recognized by the Academic Council of this University as equivalent thereof.
- III. For PGDPBT (NO. OF SEATS: 20) - B.Sc. with Biotechnology, Botany, Biochemistry, Microbiology, Agriculture Science and General B.Sc. with Botany and Zoology as compulsory subjects of not less than three Academic Years or passed some other examination recognized by the Academic Council of this University as equivalent thereof.


MODE OF SELECTION: Selection shall be purely on the performance in the Centralized Entrance Test (CET) to be held in the University Department of Botany.
