

International Legal Updates :

1. 'War crime': Danish Siddiqui's parents move International Criminal Court against Taliban. [source: - live law]

On 22/March/2022: The parents of Reuters Pulitzer Prize-winning photojournalist Danish Siddiqui have approached the International Criminal Court (ICC) against the Taliban for the July 2021 murder of their son in Afghanistan. Siddiqui's parents Professor Akhtar Siddiqui and Shahida Akhtar filed a complaint with the ICC Prosecutor to investigate his murder and bring those responsible, including Taliban leaders and high-level commanders, to justice.

3. "Right to life is mother of all rights": Malawi Supreme Court declares death penalty unconstitutional. [source: - live law]

On 02/May/2021: Malawi's Supreme Court of Appeal has declared the death penalty unconstitutional. The Court, in a majority decision of 8:1, said, "The essence of the right to life is life itself - the sanctity of life. The right to life is the mother of all rights. Without the right to life, other rights do not exist. The death penalty Not only does it nullify this right (of life), but it also destroys it." The Court made this observation while allowing an appeal by an appellant named Charles Khoviva, who was sentenced to death. The majority judgment authored by Justice D F Maungulu, referring to the provisions of the Constitution of Malawi, said that the Constitution does not contain provisions for the death penalty, on the contrary, it also curtails the right to life.

3. UN Will Investigate War Crimes in Ukraine: - By: Justine N. Stefanelli

On, May 12, the United Nations Human Rights Council passed a resolution (A/HRC/S-34/L.1) to begin an investigation into whether war crimes have been committed by Russia in Ukraine. According to a UN press release, the resolution was adopted by a vote of 33 in favor, two against, and 12 abstentions. The Council reiterated its demand that hostilities be ceased and asked that the Independent International Commission of Inquiry begin an investigation into events taking place in late February and March in several regions in Ukraine. The resolution also implores Russia to give international human rights and humanitarian institutions "unrestricted and safe access to persons who had been transferred from conflict-affected areas of Ukraine and were held on the territory of the Russian Federation or areas controlled or occupied by the Russian Federation."

4. EU Member States May Be Liable for Damage to Health from Air Pollution: -By: Justine N. Stefanelli

May 5, 2022, Advocate General Kokott issued her opinion in Case C-61/21 Ministre de la Transition écologique and Premier ministre, which arose from French proceedings instituted by a resident of Paris seeking to obtain compensation for ill health allegedly caused by France's air pollution. According to a press release from the Court of Justice of the European Union (CJEU), the Court had found Paris had been breaching the limit values set by the EU for nitrogen dioxiode and particulate matter since 2010. The Administrative Court of Appeal in Versailles, where this case originated, referred to the CJEU the question whether and to what extent a person can claim compensation from the state for damage to health caused by an infringement of the value limits.

5. ICJ Delivers Order in Ukraine v. Russia Case: - By: Justine N. Stefanelli

On March 16, 2022, the International Court of Justice delivered its Order on Ukraine's request for the indication of provisional measures in the case concerning Allegations of Genocide under the Convention on the Prevention and Punishment of the Crime of Genocide (Ukraine v. Russia). Ukraine made a number of requests, including that the Court declare that no acts of genocide have been committed in the Luhansk and Donetsk oblasts of Ukraine, contrary to the claims made by the Russian Federation.

6. *ICC Prosecutor Opens Investigation into the Situation in Ukraine: -By: Justine N. Stefanelli* On February 28, 2022, ICC Prosecutor, Karim A.A. Khan QC, announced his decision to investigate the situation in Ukraine. Mr. Khan notes that, though Ukraine is not a party to the Rome Statute, "it has twice exercised its prerogatives to legally accept the Court's jurisdiction over alleged crimes under the Rome Statute occurring on its territory, should the Court choose to exercise it." He stated that he has reviewed his Office's preliminary conclusions on the matter and has concluded "that there is a reasonable basis to believe that both alleged war crimes and crimes against humanity have been committed in Ukraine in relation to the events already assessed during the preliminary examination by the Office. He further stated that the investigation will include "any new alleged crimes falling within the jurisdiction of [his] Office that are committed by any party to the conflict on any part of the territory of Ukraine." The Office will now seek permission from the Pre-Trial Chamber to open an investigation.

7. ICJ: Uganda Must Pay Reparations to DRC: -By: Kehinde Winful

On February 9, 2022, The International Court of Justice in Armed Activities on the Territory of the Congo (Democratic Republic of the Congo v. Uganda) issued its judgment, on the questions of reparations, fixing the amount of compensation "due from the Republic of Uganda to the Democratic Republic of the Congo [DRC] for the damage caused by the violations of international obligations by the Republic of Uganda, as found by the Court in its Judgment of 19 December 2005." The judgment falls on the backdrop of a dispute concerning "acts of armed aggression" perpetrated by Uganda on the territory of the DRC. The judgment issued hundreds of millions of dollars to DRC per violations (damages) to person, property, and natural resources respectively ("loss of human life, loss of natural resources and property damage"). In total, the Court found that Uganda owed the DRC upwards of 325 million USD for violations of said obligations.



IMPORTANT DECISIONS OF THE SUPREME COURT FOR THE MONTH OF MAY 2022. [source: - live law]

1. Section 106 Evidence Act applies to cases where prosecution has successfully established chain of events: Supreme Court [Sabitri Samantaray Vs. State of Odisha]

The Supreme Court held that Section 106 of the Indian Evidence Act is applicable to cases where the prosecution has successfully established the chain of events leading to a reasonable conclusion against the accused. A bench of Chief Justice of India NV Ramana, Justice Krishna Murari and Justice Hima Kohli said, "In a case based on circumstantial evidence, whenever a questionable question is put to the accused and he either refrains from responding or gives such response, which is not true, such a reaction itself becomes an additional link in the chain of events.

2. Supreme Court transfers Gyanvapi Masjid case to the District court

The Supreme Court has transferred the Gyanvapi Masjid case filed by Hindu devotees to the civil court. A bench of Justices DY Chandrachud, Justices Surya Kant and P S Narasimha also ordered that the District Judge on an application filed before the trial court under Order 7 Rule 11 CPC to quash the suit by the Masjid Committee as being barred in law. The decision will be taken on priority basis. Meanwhile, its interim order dated May 17 will remain in force for a period of eight weeks till the application is decided and thereafter. Along with this, the concerned District Magistrate has been directed to make proper arrangements for the observance of Wuzu.

3. Hyderabad encounter fake, police version concocted, judicial inquiry commission recommends action against 10 cops for murder.

The Supreme Court-appointed inquiry commission in the Hyderabad encounter case has refuted the claims of the Hyderabad Police and concluded that the four accused were deliberately shot by the police and the police knew that the firing would lead to their deaths. A commission headed by former Supreme Court judge Justice VS Sirpurkar to probe the alleged Hyderabad encounter killings of December 2019 has found that the suspects died due to injuries sustained by bullets fired by the police party and that the police party had committed self-defense or the deceased suspects. No bullet was fired in an attempt to arrest him again, but the police knew that firing would kill the accused.

4. Permanent Lok Adalat can decide disputes on merits, but for conciliation, phased proceedings are mandatory: Supreme Court. [Canara Bank Vs GS Jayarama].

The Supreme Court has held that Permanent Lok Adalats have judicial functions under the Legal Services Act, 1987 and are thus empowered to decide disputes on merits. A bench of Justices DY Chandrachud and PS Narasimha observed that the conciliation proceedings under Section 22-C of the LSA Act are mandatory in nature. Even if the opposite party does not appear, the Permanent Lok Adalat is bound to follow a step-by-step process.

5. Hate speech: Supreme Court grants liberty to petitioners to approach vacation bench in connection with proposed Dharma Sansad programs in June-July. [Qurban Ali & Ors vs Union of India & Ors.]

The Supreme Court on Thursday granted liberty to the petitioners, who spoke about religion, to move before a holiday bench (when the court is closed for summer vacations) with regard to any hate speech at the upcoming Dharma Sansad events in June-July. Demanded action against alleged hate speeches in Parliament. A bench of Justices AM Khanwilkar, Abhay S Oka and JB Pardiwala was hearing a PIL filed by journalist Kurban Ali and senior advocate and former Patna High Court judge Anjana Prakash.

6. The power to reduce the punishment under section 302 rests with the state and not with the center: Supreme Court. [A G Perarivalan Vs State, Superintendent of Police through CBI/SIT/MMDA, Chennai, Tamil Nadu and others].

The Supreme Court on Wednesday acquitted AG Perarivalan, one of the convicts in the assassination of Rajiv Gandhi under Article 142 of the Constitution, saying that the Governor has the right of punishment under Article 161 of the Indian Penal Code, 1860. has the power to remove / reduce / waive off, as the executive power of the State extends to the said provision. Justice L Nageswara Rao, Justice BR Gavai and Justice AS Bopanna were unable to accept the submission made by Additional Solicitor General KM Nataraja that the President had the right to waive or remit the sentence awarded under the provisions of the Indian Penal Code. or has special power under article 72 to reduce.

7. Section 482 CrPC - Criminal proceedings cannot be quashed merely on the ground that "no useful purpose will be served": Supreme Court. [Satish Kumar Jatav vs State of UP].

The Supreme Court held that when a clear case is made out for the alleged offences, the criminal proceedings cannot be quashed merely on the ground that "no useful purpose will be served by prolonging the proceedings of the case". A bench of Justices MR Shah and BV Nagarathna reiterated that a High Court should pass a cogent and reasoned order while disposing of the petitions under Section 482 of the Code of Criminal Procedure.

8. Double Insurance: When one insurer has fully indemnified the loss, the other insurer can reject the claim -Supreme Court. [United India Insurance Company Limited Vs Lewis Strauss (India) Pvt Ltd]

The Supreme Court recently held that in cases of overlapping insurance policies, when one insurer has fully compensated the loss (defined loss) to the insured, the other insurer will not be liable for the claim made for the same event. "The contract of insurance to indemnify a defined loss is always one and the same, neither more nor less. The insured cannot benefit from double insurance for specific risks, such as loss due to fire, etc.."

9. Any order passed by the National Consumer Disputes Redressal Commission can be challenged in a writ petition under Article 227 of the Constitution before the High Court: Supreme Court. [Ibrat Faizan Vs Omaxe Buildhome Pvt Ltd]

The Supreme Court has held that any order passed by the National Consumer Disputes Redressal Commission (NCDRC) in appeal under Section 58 (1) (a) (iii) of the Consumer Protection Act, 2019 should be placed before the High Court in the Constitution. can be challenged in a writ petition filed under Article 227 of the A bench of Justices MR Shah and BV Nagarathna observed that the NCRDC is a "tribunal" covered under Article 227. The Article 227 petition filed against the NCDRC order in question before the Supreme Court was adjudicated as maintainable.

10. Supreme Court stays sedition law; New cases will not be registered till reconsideration

In a historic development, the Supreme Court on Wednesday ordered that the 162-year-old sedition law under Section 124A of the Indian Penal Code should be kept in abeyance until the central government reconsiders the provision. Does it in an interim order, the Court urged the Central and State Governments to refrain from registering any FIR under the said provision till it is reconsidered.


High Court Judgements :

Prabha Minz Vs Martha Ekka & Ors.

A Oraon tribeswoman Prabha Minz had approached a Ranchi Court demanding justice after being denied her due share in paternal property but her petition was rejected, citing customary laws. She then appealed to the Jharkhand High Court. But, even here her first appeal was turned down on similar grounds. Thereafter, she made a second appeal before the High Court. The hearing of the petition was completed on February 22, but the order was kept reserved.

On Friday (April 22), setting aside the judgment and decree passed by the Courts below, Justice Gautam Kumar Choudhary, in his order ruled that as none of the parties have been able to prove that the customary laws denied paternal property rights to Oraon women, the petitioner ought to be given due share in her paternal property.







State of Kerala Vs Kirankumar :

A Kerala trial court issued its long-awaited judgement in the spectacular dowry death case in which 22-year-old Vismaya V Nair was found dead at her in-laws' residence in June 2021, purportedly of suicide owing to dowry harassment and domestic violence. In an incident that shook the State last year, Vismaya, an Ayurveda medical student was found dead in her matrimonial home under mysterious circumstances after she had complained of dowry harassment. Kiran Kumar was charged under Sections 304 (B), 498 (A), 306, 323 and 506 of IPC for dowry death, inflicting physical or mental harm, abetment of suicide, voluntarily causing hurt and criminal intimidation. He has been convicted under section 304(B),498(A) and 306. The prosecution relied primarily on digital evidence to prove its case. This is possibly the first dowry harassment case in which a major fragment of digital evidence was used to determine the accused's guilt. The court examined 42 witnesses, 108 documents, and many call records during the course of the trial. The police filed a 507-page charge sheet alleging that Vismaya committed suicide as a result of dowry harassment.

Dr Rajneesh Singh v. Union of India and Ors A petition has been filed before the Lucknow bench of Allahabad High Court seeking a direction to the Archaeological Survey of India (ASI) to open the sealed doors of over 20 rooms inside the Taj Mahal premises so that the alleged controversy pertaining to the "history of Taj Mahal" can be put to rest.

The petition filed by one Dr Rajneesh Singh seeks a direction to the government to constitute a fact-finding committee to study and publish the 'real History of Taj Mahal' and to put to rest the controversy surrounding it.



RTI Foundation v. Union of India:-The Delhi High Court on 11/May/2022 passed a split verdict on a petition challenging the exception to section 375 of the Indian Penal Code, which exempts forceful sexual intercourse by a man with his wife from the offence of rape. Justice Rajiv Shakdher has held that the exception to the husband from the offence of marital rape is unconstitutional. Exception 2 of 375, 376B IPC was therefore struck down by him as a violation of Article 14 of the Indian Constitution. However, Justice C Hari Shankar said that he does not agree with Justice Shakdher.Justice Harisankar has held that Exception 2 to section 375 does not violate Constitution and that the exception is based on an intelligible



S Narayanan Vs State of Tamil Nadu

The Madras High Court recently observed that rituals and observations prescribed under a religion that form an integral part of that religion are also covered under the freedom of religion enshrined under Article 25(1) of the Constitution. This right of worship guaranteed under the Constitution must be respected by all concerned and devotees cannot be denied their right of worship under any circumstances.
