



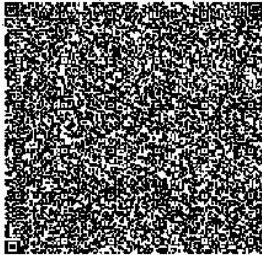

**MEMORANDUM OF UNDERSTANDING
BETWEEN
INDIRA GANDHI NATIONAL CENTRE FOR THE ARTS, NEW DELHI

RANCHI UNIVERSITY, RANCHI, JHARKHAND**

1. This Memorandum of Understanding is made on the 10 / 02 / 2017 between Indira Gandhi National Centre for the Arts, New Delhi hereinafter referred to as IGNCAR, Ranchi, Jharkhand, which unless repugnant to the context would include their successors,

assigners, agents and executor on one part and Ranchi University, Ranchi, Jharkhand hereinafter referred to as RU which unless repugnant to the context shall include their successors, assigners, agents and executor on the other part.

2. IGNCAs an academic and cultural research institution. It is an autonomous Trust under the Ministry of Culture, Government of India. It has in its mandate the objectives to pursue studies in 'the arts'. The arts is here understood to comprise the fields of creative and critical literature, written and oral; the visual arts, ranging from architecture, sculpture, painting and graphics to general material culture, photography and film; the performing arts of music, dance and theatre in their broadest connotation; and all else in fairs, festivals and lifestyle that has an artistic dimension.
3. Ranchi University is a state administered University located at Ranchi, Jharkhand, India. Right since its inception, RU has been fulfilling the ever increasing demands of higher education. A teaching-cum-affiliating institution, RU stands to establish and incorporate a teaching and research for the promotion and development of Science, Social Sciences, Language, Literature, Commerce and Vocational courses.

4. INTENT OF WORK


Through this Memorandum of Understanding, based on the principles of equality, reciprocity and mutual benefit, IGNCAs New Delhi and RU, Ranchi hereby agree to set up Regional Centre of IGNCAs at Ranchi to undertake activities focusing on the lifestyle study of the various indigenous and ethnic groups besides academic programs on culture and holistic approach of art-forms in Jharkhand and worldwide.

RU has agreed to provide sufficient space for setting up the IGNCAs Regional Centre at their premises to study and for dissemination of knowledge in the field of art and culture. There would not be any financial implications on the part of RU for its setting up.

In collaboration with RU, initially for a period of five years, IGNCAs seeks to enlarge its network with the institutions, contribute to the promotion of Indian Culture and art-forms among the youth, students and people at large.

IGNCAs Regional Centre at Ranchi would develop Library and Archive of print and digital Resources for the study of art and culture.

Both the institutions will form a joint faculty staff as members of Advisory Committee or Joint Supervisor/Co-guide for Ph.D. scholars.

Both the institutions will offer credit/non-credit courses to students in the fields of Sanskrit, Textual research, Vedic studies, Translation studies, Manuscriptology, Oral Traditions, Folklore, Traditional knowledge system, Performing arts, Storytelling traditions, Cultural informatics, Conservation, Diaspora, Media and Communication, Social work and other area studies.

5. BENEFITS TO IGNC A FROM THIS COLLABORATION


- (i) Substantial outreach opportunities for IGNC A, to reach the youth and students engaged in the concerned fields.

6. BENEFITS TO RU FROM THIS COLLABORATION


- (i) Access to IGNC A's research materials and human resources.
- (ii) Opportunity to expand the nature of courses offered based on additional resources to be made available through this agreement.
- (iii) Inclusion of RU in media campaign and other publicity material.

7. ARBITRATION

Except in noting the existence of this Educational Partnership Agreement, no use of the name, symbols, signs or trademarks of one institution shall be used by the other. This agreement shall become effective on the date of its signing and continue thereafter for five years subject to revision or modification by mutual agreement and unless terminated by either of the two parties hereto. Termination by one institution shall be effected by giving the other institution at least ninety (90) days' advance written notice of its termination- in such circumstances, any student/ researcher who has commenced study at either institution on or before the date of the termination, may complete their study program. Termination shall be without penalty.
