WHEREAS, the afore mentioned parties desire to enter into the herein described agreement in which they shall work together to accomplish the goals and objectives set forth.

AND WHEREAS, the parties are desirous to enter an understanding, thus setting out all the necessary arrangement that both parties agree shall be necessary to complete this MOU.

PURPOSE & SCOPE:

The parties intend for MOU to provide the corner stone & structure for any & all possibly impending contract which may be related to the shooting range or shooting sports.

OBJECTIVES:


The parties shall endeavour to work together to develop and establish policies & procedures that will promote & sustain the shooting sports & intend to maintain the respect & level of shooting standard as per the regulations of N.R.A.I. (National Rifle Association of INDIA)


MISSION:

The afore mentioned MOU has been established with the following intended mission in mind:

- To promote & develop maximum numbers of players from the university as well as the state.

The term of this MOU shall be for a period of 03(three) years, from the afore mentioned effective date and may be extended upon written mutual agreement of both the parties. However in case of any deviation from the agreement, both the parties will be free to withdraw after a notice of three months either way.

AMENDMENT OR CANCELLATION OF THIS MEMORANDUM:

This memorandum of understanding may be amended or modified at any time in writing by mutual consent of both the parties.

In addition to this the MOU may be cancelled by either parties with pre notice of 03 (three) months.

With the exception where cause of cancellation may include, but is not limited to, a material and significant breach of any of the provisions contained herein, when it may be cancelled upon delivery of written notice to the other party.

MOU SUMMERIZATION:

FURTHERMORE, the parties to this MOU have mutually acknowledged and agreed to the following:


- Ranchi University will construct a shooting range in their desired location preferably at morabadi or any nearby place in constituent college campus.
- Ranchi University will be having full control of the management as well as the recruitments and the administrative body of the shooting range. However in the board, one member of the Jharkhand State Rifle Association will be present.
- Ranchi University will have total control over the revenue generated by the shooting range by the means of membership or any bookings of the shooting range by the club or association.
- Jharkhand State Rifle Association will give recognition/affiliation to the Ranchi University or the Shooting Range constructed by Ranchi University.
- Jharkhand State Rifle Association will help and give all the support needed for proper conduct of the matches or shooting events which will be held at the shooting range.
- Jharkhand State Rifle Association will make sure that all the shooting events which will occur in the shooting range must be conducted by the rules & regulation of N.R.A.I. (apart from regular trainings or practice matches).


AUTHORIZATION & EXECUTION:

FINANCE & CERTIFICATES:

The trained person/student will be given certificate under the dual banner of Ranchi University and Jharkhand State Rifle Association under the official seal clearly mentioning the registration number, so that the certificates could be valid in Indian union for any development/service/better future of the students.


