

## MEMORANDUM OF UNDERSTANDING

Memorandum of understanding between the JHARKHAND WUSHU ASSOCIATION (hereinafter known as JWA) & RANCHI UNIVERSITY (hereinafter known as RU)

### PREAMBLE

The Jharkhand Wushu Association an affiliated unit of Wushu Association of India & Jharkhand Olympic Association and Ranchi University hereinafter called the Partners." found it mutually beneficial to have a formal understanding between the two Partners in taking up collaborative sports programmes for Wushu Sports at Ranchi University Campus, Saheed Chowk, Ranchi. Both the parties will make use of its own resources along with strength and experiences of JWA to contribute to the ongoing process of developmental programme for Wushu to achieve sustained development and progress in the sports of Wushu for the State Players and the players of the Ranchi University.

### **1. THE PARTNERS**

The partners of this Memorandum of Understanding are the JHARKHAND WUSHU ASSOCIATION & RANCHI UNIVERSITY represented by the General Secretary and or his nominee on one side and the vice-Chancellor or his nominee represented on the other side

### **2. DETAILS OF UNDERSTANDING**

The partners, after due consideration of various aspects have arrived at the following understanding in respect of the Sports projects mentioned in the earlier paragraphs

# The Jharkhand Wushu Association will provide free of cost, training to the Wushu players of Ranchi University which may include deployment of trained Coach time to time.


# The Jharkhand Wushu Association will also provide necessary technical assistance to Ranchi University in organizing different level of Training/Competition/Selection/Tournaments without any financial liability, whenever required.

# The R U will provide space for the Wushu training Center at Ranchi University campus and Jharkhand Wushu Association will use the same for conduct of Wushu Regular Training, Camp, Seminar, Workshop on SELF-DEFENSE etc. only.

# The intention to use the Ranchi University Wushu Coaching Centre in R U Campus, Saheed Chowk, Ranchi provided by RU is for Wushu only . For any other project has to be notified in advance and written permission of RU has to be obtained in consultation with JWA

#The maintenance of the play ground will be the responsibility of JWA. However the maintenance of other areas shall rest with R u.

# RU shall arrange equipments ie. Mat, Sanda Set, Taolu Set as and when required for its players.

# JWA shall assist the RU in selection/Training, however it shall not take the responsibility of the selection criteria for the Team of RU.

This Memorandum of understanding will come into effect on the date of signature and will remain in force until either side delivers written notification to the other of its intention to terminate the Memorandum, in that case it will terminate six months after the receipt of such a notification.

**4. MODIFICATION**


The MOU may be amended by mutual consent through an exchange of correspondences between the two partners.
