News & Judgments

Legal News:

- 1. Collegium System of Appointment Should be Reconsidered: Kiren Rijiju Union Law and Justice Minister Kiren Rijiju suggested on Saturday 19th September, 2022 that the collegium system be reconsidered in order to speed up the appointment process in higher judiciary, citing concerns about the current process.
- 2. Police Arrests 72-year-old Fake Woman Lawyer in Mumbai, Who Was Practising Law for 14 years

On Saturday, the BKC Police detained a 72-year-old woman who had been practising law in Mumbai without a legal degree since 2008.

3. All Constitution Bench Matters in Supreme Court To be Live Streamed From September 27

On Tuesday, a full court comprised of all of the Supreme Court's judges decided to live stream all constitution bench matters.

4. Koffee With Karan" Show Insults Modesty of Women- PIL Filed in HC Seeks Criminal Action Against Karan Johar and Makers

A Public Interest Litigation petition has been filed before the Calcutta High Court against the famous talk show 'Koffee With Karan,' stating that it corrupts the brains of youths and feeds the lustful appetites of men while also insulting a woman's modesty.

5. UP Assembly Passes Amendment Bill Denying Anticipatory Bail in Crimes Against Women and Children

Uttar Pradesh Legislative Assembly on Friday passed the Code of Criminal Procedure (Uttar Pradesh Amendment) Bill 2022 which bars granting of anticipatory bail to rape accused.

6.Mukul Rohatgi Declines Government's Offer to be Next Attorney General of India

In a recent interview to a news portal, Senior Advocate Mukul Rohatgi has said that "I had second thoughts" about accepting Government's Offer of Office of Attorney General.

7. Senior Advocate R Venkataramani Appointed as Next Attorney General of India

On Wednesday, September 28th ,2022, Ministry of Law and Justice issued a notification about appointment of Attorney General of India.

Supreme Court Judgements:

1. Accused's Offer Of Payment Of Ad Interim Compensation To Victim Cannot Be A Ground For Granting Bail: Supreme Court

The Jharkhand High Court released one of the accused on bail only on the ground that one of the co-accused person has already been enlarged on bail by the co-ordinate Bench and that the accused is ready to deposit ad interim compensation amount of Rs.1,00,000/- in favour of the victim. The State therefore approached the Apex court challenging this order of High Court. Setting aside the order, the bench requested the High Court to hear and dispose of the bail application of the accused on merits within a period of thee months.

2. Murder Convict Cannot Be Sentenced To Punishment Less Than Life Imprisonment: Supreme Court

There cannot be any sentence/punishment less than imprisonment for life, if an accused is convicted for murder offence under Section 302 of the Indian Penal Code, the Supreme Court observed in a judgment on 2nd September 2022.

3. Successive FIRs By Same Informant Against Same Accused On Same Allegations Impermissible, Violate Articles 21 & 22: Supreme Court

The Supreme Court observed that registration of multiple FIRs by same person against same accused based on the same set of facts and the same cause of action is Impermissible. "The act of the registration of such successive FIRs on the same set of facts and allegations at the instance of the same informant will not stand the scrutiny of Articles 21 and 22 of the Constitution of India", the Court observed.

4. Supreme Court Dismisses Plea Seeking Amendment Of Hindu Succession Act As Recommended In 204th Law Commission Report

The Supreme Court dismissed a writ petition seeking direction to amend the Hindu Succession Act 1956 as recommended by the Law Commission of India in its 204th report. The bench comprising Justices DY Chandrachud and Hima Kohli noted that the petitioner (S. Venkatesh) is not an aggreived person.

5. "Marital Rape Exception For Husband Unconstitutional": AIDWA Moves Supreme Court Challenging Exception To Section 375 IPC

The Supreme Court of India on Friday adjourned a batch of petitions filed against the split verdict passed by a Two-judge Bench of the Delhi High Court on the criminalisation of marital rape. During the hearing, a Bench of Justices Ajay Rastogi and BV Nagarathna said that it would tag all similar matters together and hear on September 16.

6. Supreme Court Refuses To Entertain PIL Seeking To Examine Link Between Pornography & Sexual Crimes.

The Supreme Court, on Monday, refused to entertain a petition seeking to formulate a Standard Operating Procedure (SOP) by the police to examine the impact of viewing of pornographic material while investigation a sexual offence case. The matter was heard by a bench comprising Chief Justice U.U. Lalit and Justice Ravindra Bhat.

- 7. Denial of Pension is a Continuing Wrong: Supreme Court
 The Supreme Court on Monday stated that, denial of pension is a continuing
 wrong. The Court cannot also be oblivious to the difficulties of a retired
 employee.
- 8. After 10 Days of Hearing Supreme Court Reserves Judgement in Hijab Case After a 10-day hearing, the Supreme Court today reserved its Judgement on a batch of petitions challenging the Karnataka High Court's decision upholding the ban on Muslim students wearing hijab.

9. Disciplinary Enquiry | HC Should Remit the Matter Back For Re-inquiry From the Stage It Stood Vitiated: Supreme Court

The Supreme Court on Friday stated that where the High Court finds that Disciplinary Enquiry has been conducted against the principles of natural justice and in violation of the procedure prescribed, the appropriate order is to remit the matter back to re-enquire from the date it stood vitiated.

10. Any Circular, Executive or Administrative Order Can't be Applied Retrospectively in Absence of Any Legislative Competence, Rules Supreme Court

The Supreme Court recently ruled that administrative/executive orders or circulars can't be made applicable with retrospective effect in the absence of any legislative competence.

11. Unregistered Document/Agreement to Sell is Not Admissible as Evidence in Permanent Injunction Suit: Supreme Court

The Supreme Court on Friday ruled that an unregistered document/agreement to sell shall not be admissible as evidence in Permanent Injunction Suit.

12. Bail Parity | Reasons Must be Indicated in Order as to How the Case is Identical, Rules Supreme Court

The Supreme Court on Friday stated that, in case of a serious offence such as murder, the liberty of the accused has to be necessarily balanced with the public interest. The High Court should state reasons as to how the case of co accused is identical to the accused who has been granted bail.

13. Supreme Court live-streams Constitution Bench proceedings

the Supreme Court started live streaming its proceedings on 27th Sep, 2022m Tuesday. The streaming of three separate constitutional benches is live on webcast.gov.in/scindia/

High Court Judgement:

1. S.278 CrPC | Witness Can't Be Allowed To Seek Correction In Evidence After He Signs Deposition Sheet: Orissa High Court

The Orissa High Court has held that a witness cannot be allowed to seek modification or correction in his deposition statements, which are recorded through his examination-in-chief and cross-examination, after the evidence/statements were read over to him and subsequently, he puts his signature on deposition sheets. The Court however clarified that if any new fact is there with the witness which he has inadvertently left out, his counsel can file an application for recall to depose only those aspects.

- 2. Hindu Deities Were Worshipped Inside Gyanvapi Mosque Complex Even After Aug 15, 1947; Places Of Worship Act No Bar To Suit: Varanasi Court The Varanasi Court today dismissed the Anjuman Islamia Masjid committee's plea (filed under Order 7 Rule 11 CPC) challenging the maintainability of the suit filed by five Hindu women (plaintiffs) seeking worshipping rights in the Gyanvapi Mosque compound. District Judge Ajay Krishna Vishwesha observed that the suit of the plaintiffs is not barred by the Places of Worship (Special Provisions) Act, 1991, The Waqf Act 1995, and the U.P. Shri Kashi Vishwanath Temple Act, 1983 as was being claimed by the Anjuman Masjid Committee (which manages Gyanvapi Masjid).
- 3. Parties Can Deviate From Terms Of Jurisdiction Under The Arbitration Clause Only Once: Madras High Court

The Madras High Court has ruled that the parties have got the liberty to deviate from the terms with respect to the jurisdiction, as contained in the Arbitration Clause; however, the number of such deviations is limited to only one. The Single Bench of Justice R.N. Manjula held that waiver of the jurisdiction clause contained in the arbitration agreement can be presumed from the conduct of the parties. The Court added that if the parties have waived the earlier agreement on jurisdiction and have substituted a new jurisdiction by conduct, then, in view of Section 42 of the Arbitration and Conciliation Act, 1996 (A&C Act), the parties cannot make any further diversions with respect to the jurisdiction.

- 4. Competition Act | Order Of Inquiry U/S 26 Does Not Affect Parties' Rights, Opportunity Of Hearing Not Mandatory: Gujarat High Court
- The Gujarat High Court has held that an order of inquiry under Section 26 of the Competition Act is only a prima facie opinion and does not affect the rights of any person. Thus, it held that such an order cannot be reviewed by the High Court unless and until it is shown that it is contrary to the provisions of the Act or the order has included irrelevant material or not included relevant material.
- 5.Where Commissioner Of Police System Exists, District Magistrate Is Not "District Authority" Under Petroleum Rules, 2022: Madhya Pradesh High Court

The Madhya Pradesh High Court, Indore Bench recently held that only the Commissioner of Police and not the District Magistrate would be empowered to revoke the No Objection Certificate (NOC) given to a petrol pump under Rule 150 of the Petroleum Rules, 2002, where the Commissioner of Police system is in existence.

6. Marriage is Not for Pleasure, The Main Purpose is Progeneration: Madras HC

Recently, Madras HC stated that, Marriage is not for mere satisfying the carnal pleasure, but it is mainly for the purpose of regeneration.

7. Delhi Court Dismisses Plea Claiming Ownership of Qutub Minar and Entire South Delhi

On Tuesday, Delhi's Saket court dismissed the application of Kunwar Mahendra Dhwaja Prasad Singh, who sought to be made a third party by claiming ownership rights to the land.

8. HC Seeks Explanation From District Court Judge For "Copy-Pastes Judgement"

In a significant order, the Punjab and Haryana High Court has directed District & Sessions Judge, Gurdaspur to randomly check ten judgements of a judicial officer to determine if he has indulged in any sort of plagiarism.

9. Insurance Company Liable to Compensate Even If Driver Died Due to Heart Attack in Parked Vehicle: Karnataka HC

Recently, Karnataka HC ruled that The insurance company is liable in the case of death of the driver of an insured vehicle.

10. Mere Pendency of Defective Criminal Revision Would not Create any Embargo on Grant of Service Benefits: Allahabad HC

The Allahabad HC at Lucknow on Tuesday ruled that in case a criminal revision defective is registered, it cannot be said that there are criminal proceedings still pending against the petitioner

11. Wife's Opposition to Husband's Demand For Living at a Place Other Than His is Not Cruelty: Chhattisgarh HC

The High Court of Chhattisgarh recently observed that if a husband asks his wife to stay at a place other than his without sufficient cause and she opposes it, it cannot be termed as cruelty on her part. The observation was made by Justice Goutam Bhaduri & Justice Radhakishan Agrawal in its decision on an appeal filed by a man against the family court's decision to not allow his petition for divorce on the ground of cruelty.

12. Sec 357 CrPC | Where Fine Imposed U/Sec 138 NI Act, Court Ought to Order Compensation From Fine: Kerala HC

Pay Dignified Salary/Stipend to Juniors: Delhi HC Urges Senior lawyersRecently, Kerala HC ruled that where a fine is imposed under section 138 NI Act the court ought to order compensation from the fine.

13. Habeas Corpus | Both Mother and Father are Natural Guardians of their Children, Therefore It Can't be Held That Custody of Father is Illegal: Allahabad HC

The Allahabad HC on Thursday stated that, in case of inter-parental conflict, a child may be affected by relationship distress, therefore parents are advised to settle their differences to fulfil the wish of Corpus/Child.

14. Court Cannot Grant Divorce Without Disposing Maintenance Pendente Lite Application: Bombay HC

Recently, Bombay HC ruled that a decree of divorce cannot be granted without dosping maintenance pendente lite application under Section 24 HMA.

15. JJ Act | Radiological Age Test Can be Ordered When There is Contradiction in School Leaving Certificate and Other Evidence Regarding Age: Allahabad HC

The Allahabad HC on Thursday ruled that the courts below cannot be faulted for depending upon the medical/radiological age of the juvenile and declaring him as an adult.

16. Criminal Proceedings Cannot Be Quashed If Reinstatement in Service is Without Clean Chit In Departmental Inquiry: JKL HC

On Thursday, the Jammu & Kashmir & Ladakh High Court ruled that mere reinstatement into service without getting a clean chit in a departmental inquiry is not a ground to quash the criminal proceedings that started due to the said allegations.

17. Daughter Repeatedly Demanding Money From Her Father Can't be Prosecuted For Abetment Of Suicide, Rules Bombay HC

The Bombay High Court (Nagpur Bench) has ruled that repeated monetary demands from a daughter to her father won't attract the offence abetment of suicide.

- 18. Pay Dignified Salary/Stipend to Juniors: Delhi HC Urges Senior lawyers The Delhi High Court has requested senior lawyers to pay an adequate stipend to their juniors so they can overcome financial stress and lead a more dignified life.
- 19. HC Suspends ADJ on Allegations of Sexual Harassment of a Woman Lawyer

The Additional District and Sessions Judge (ADJ) in Haryana's Bhiwani is accused of sexually assaulting a female lawyer. According to the charges, the Judge invited her to his chambers.
